Driving north and south of the Norfolk Southern Railroad through the City of Circleville has always been a challenge. If these crossings are left un-addressed travel delays will continue to impact not only the travelling public, but also safety forces travelling to emergencies. A feasibility study is underway and will be finalized in 2024. There are currently a few alternatives being discussed. As the study concludes, there will be a public meeting to address the findings and the preferred alternative(s). #### NORTHERN PICKAWAY TRANSPORTATION PLAN

**PROGRESS UPDATE** 

Kimley-Horn was hired by the Pickaway County Transportation Improvement District (TID) to study 23 miles of U.S. 23 through Pickaway County. This study will serve as a tool for the County and other stakeholders to proactively support the growing transportation demands in the area. This study includes Scioto Township, Harrison Township, and Madison Township in Pickaway County. The preparation of this plan for the Pickaway County TID, will serve as a tool for Pickaway County and other stakeholders to use in preparation to address traffic impacts from site development projects prior to rather than reactively. ### SR 762 & US 23 INTERCHANGE

**Northern Pickaway County is** located near a major logistics hub and is a key economic center in the Central Ohio region. Two of the main roadways in this area are U.S. 23 and S.R. 762 (Duvall Road). This intersection has been identified for improvement by ODOT District 6, due to current and proposed development near the area. This project is currently in the planning phase and no decisions have been made at this time. All findings will be documented in a feasibility study. Using this study, ODOT plans to make a Recommended Preferred Alternative following public involvement and detailed analysis.
