

CSX PLATINUM SELECT SITE DESIGNATION, RICKENBACKER SOUTH INDUSTRIAL RAIL PARK


CSX Transportation recently announced the Rickenbacker South Industrial Rail Park, a nearly 700-acre site in northern Pickaway County, has been designated a CSX Platinum Select Site, marking it as one of the nation's premier industrial sites. Located west of the CSX mainline off Bulen Pierce Road, this designation emphasizes the park's readiness for large-scale industrial projects that bring high-paying jobs, offering exceptional rail and logistics capabilities for businesses.

The Platinum Select Site status meets strict standards for infrastructure and connectivity. "This achievement reflects Pickaway County's commitment to world-class infrastructure to attract advanced manufacturing investment with high paying local jobs," said Tim Colburn, Executive Director of Economic Development at P3, underscoring the county's standing as a prime location for economic growth in Central Ohio.
